The calculator labels the full-term date as Lifetime / Upon Death and treats the remaining term as Lifetime, not as a fixed-year term. The supervisee has completed 36.0 months of supervision. The revocation probability at the current month and criminal history category is 1.83%. The threshold for dropping below 5% is 11/23/2024. The full-compliance date is 05/23/2025. Government position is shown separately and is not used to determine qualification or recommendation. A high-risk flag is present, but the case remains in play only if the minimum standard is met, the revocation probability is not above 5%, and no serious present-tense concerns are marked no.
